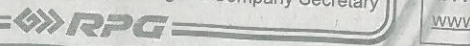

- 1] The audited financial results have been reviewed by the Audit Committee and adopted to the Board of Directors. The Board of Directors of the Company has approved the same at its meeting held on 3 May 2017.
- 2] The Statutory Auditors have audited the standalone financial statements for the year ended 31 March 2017 and have issued an unqualified opinion thereon. The information is based on the audited financial statements as stated.
- 3] The figures of the last half-year in each of the years are the balancing figures in respect of the full financial year and the unaudited published figures of the respective year.
- 4] The Company is primarily engaged in the business of housing finance. Separate information is required to be furnished in terms of Accounting Standards prescribed under Section 133 of the Companies Act, 2013.
- 5] Debentures are secured by first charge ranking pari-passu with each other.
