RPG Life Sciences revenue up 18%; profit at Rs 11.62 crore

- FY16 revenue at Rs 274.54 cr vs Rs 233.08 cr YoY
- EBITDA stands at Rs 23.50 cr, a growth of 66% YoY

Mumbai, April 29, 2016: RPG Life Sciences Ltd. (RPGLS), part of the RPG Group, engaged in manufacturing and marketing of pharmaceutical products, has announced the audited financial results for the financial year ended March 31, 2016.

The company's net sales stood at Rs 274.54 crore as against Rs 233.08 crore for the previous year, a surge of 18%. The company registered a robust growth in PAT for the current year to stand at Rs 11.62 crore as against Rs 1 crore in the previous year. EBITDA for the year surged to Rs 23.5 crore as against Rs 14.20 crore for the last year, a growth of 66%. Margins grew by 250 bps to stand at 8.6%.

"This year's performance has been driven by robust growth in domestic formulations and international business. Focused brands like MINMIN and Traicaine have grown by 62%. Good order flow from generics market also added to our top line and bottom line. Overall, it was a year of consistent growth on quarter on quarter basis," commented Mr CT Renganathan, Managing Director, RPG Life Sciences Ltd.
